

Student Comments

Below are samples of student comments given on the official University of North Texas Student Evaluation of Teaching Effectiveness or Department evaluations regarding the instructor (Nicholas Higgins). Each student's response is provided anonymously and therefore they are allowed to speak freely. The comments are provided to the university administration through an online portal, which then compiles these comments and sends them in a document to the professor. These comments are divided into the semesters in which I have taught and have not been edited; therefore any grammar and spelling errors are the students'.

Spring 2014:






About SETETM

 $SETE^{\text{TM}} \ is \ a psychometrically \ valid faculty \ teaching \ evaluation \ instrument \ that \ minimizes \ bias \ by \ controlling \ for \ student \ demographic \ influences. The per-course outcome is a single numerical \ value \ of a faculty member's \ effectiveness \ on \ a scale \ of \ 1 - 1000. The \ SETE^{\text{TM}} \ Scale \ Score \ replaces \ the \ raw \ distribution \ score \ normally \ seen \ on \ end-of-course \ survey \ reports.$

The scale scores shown below are on an interval scale similar to that used by other standardized tests such as SAT or GRE. Course means are computed for each of the three effectiveness sub-factors: Organization and Explanation of Materials, Learning Environment, and Self-Regulated Learning. An overall (general factor) effectiveness mean is computed for each course. The overall mean (SETETM Score) for each course should be used to infer the degree to which an instructor's teaching is perceived by students to be effective. The intent is that the scores can be applied to a continuous improvement model that shows individual instructor growth over time. Instructors can have confidence in the scale score recognizing that factors of student bias have been controlled.

Organization and Explanation of Materials

The Organization and Explanation of Materials Sub-Score reflects the student's perception of how well the instructor: makes the course requirements and student learning outcomes clear to the students; gives assignments, activities, and materials that are helpful and that contribute to understanding the subject; explains difficult material clearly; shows the relationships among topics and new concepts; and evaluates student work in ways that are helpful to learning.

Learning Environment

The Learning Environment Sub-Score reflects the student's perception of how well the instructor: establishes a climate of mutual respect and encouragement; motivates students to work and engage in learning; is available and encouraging; is skillful in actively engaging students in learning; and provides useful feedback.
